Below is the list of SEVRAR endorsed candidates for the 2018, primary (August 30) and general (November 8) elections.

Motion:

The SEVRAR Government Affairs and RAPAC Candidate Selection Committee makes the following motion/set of recommendations to the Board of Directors for 2018, local government candidates:

(Apache Junction)

That the Board endorse Apache Junction Councilman David Waldron to serve as Mayor, in addition to a \$1,500 RAPAC contribution; and endorse Councilwoman Gail Evans for re-election with no RAPAC support as indicated on her application.

(Mesa)

That the Board endorse Jacob Brown for the Mesa District 4 Council seat with a RAPAC contribution of \$1,000

(Gilbert)

That the Board endorse Councilpersons Brigitte Peterson, Jordon Ray and Barbara Guy for re-election to the Gilbert Council with \$1,000 in RAPAC support each.
