GENERAL RULES

All applications must be completely and accurately prepared including listing and selling names or brokerage names. Any columns left blank on the application may result in disqualification.

All qualifying transactions must have closed while the applicant was an active member in good standing with SEVRAR. (Dues must be current at the time application submission).

By signing the application, both the applicant and the Broker certify that all transactions and computations are submitted in compliance with these rules. If application contains transactions closed while the applicant was affiliated with, or employed by another Designated REALTOR® during the qualifying period, the Designated REALTOR® endorsing this application warrants that sufficient investigation had occurred to verify the accuracy of the application.

SALES VOLUME CALCULATION

HOW TO CALCULATE SALES VOLUME

Example: The sale price of a property was \$100,000.

- A. If you were the listing agent on the property AND you were the selling agent on the property, your gross sales volume would be \$200,000.
- B. If you were the listing agent on the property BUT another agent was the selling agent, your gross sales volume would be \$100,000.
- C. If the property was listed through another company BUT you were the selling agent, your gross sales volume would be \$100,000.
- D. If you receive a referral fee or sales fee, you may claim gross sales volume to the degree to which you participated. *(If you received 25% of the commission or sales fee, you would receive 25% of the volume).*
- E. On Residential Leasing volume, your gross sales volume for credit would be the amount of the monthly rent multiplied by the length of the lease (number of months).
- F. On-site new home sales persons gross amount would be \$100,000.
