



# SECURE LOCKBOX PROGRAM

Are you concerned about how the **police** and **fire** departments would get into your home if you (or someone you know) were alone, unconscious or unable to get to the door?

The **Secure Lockbox Program** is primarily for elderly residents who live alone, physically challenged, or have a medical condition with a probability that is necessary to call 911 for assistance.



## How does the program work?

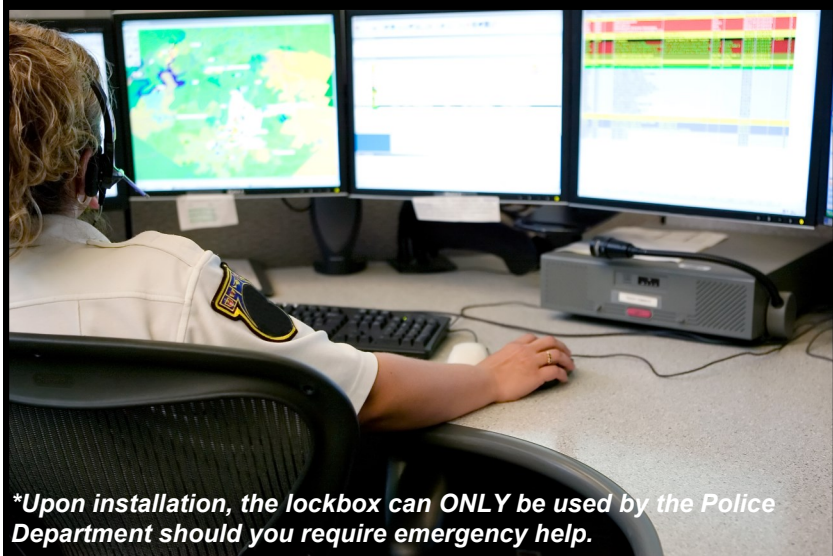
The **SEVRAR Community Outreach Committee** will administer the program while the **Gilbert Fire & Rescue Community Services Department** will individually assign lockboxes. In addition, information, installation, and access attached to each lockbox will be stored in the participating Police Department's Computer Aided Dispatch Database. This allows for storage of confidential information and creates a systematic emergency response. The best part of the program is that it's free to qualifying residents.

The program is designed to allow **police, fire, and emergency personnel** to access a home in emergency situations where **the likelihood that forced entry is necessary.**

## FOLLOW THESE EASY STEPS TO GET YOUR SECURE LOCKBOX!

1. Thoroughly **read** the information provided above. For questions about the program, please contact SEVRAR at 480-833-7510.
2. Complete the Secure Lockbox Program **Application**.
3. Once application is complete, **please contact** Gilbert Fire & Rescue Community Services Department to schedule appointment at 480-503-6300.
4. You will be contacted regarding your application status. **Upon approval** your residence will be added to the lockbox installation schedule.
5. Lockboxes are **installed** one (1) designated day per month by authorized personnel. You will be contacted prior to that exact date to ensure someone is present during the lockbox installation.
